

IFC Council Alcohol Policy Revised Spring 2005

Overview:

The objective of this policy is to limit the instances where hazing becomes more physically harmful due to the incorporation of large amount of alcohol. Studies have shown that drinking is directly related to the performance of behaviors that are excessive and irresponsible (Johnson 2004). Being realistic in our approach to trying to produce a remedy for hazing, we should note that making it more difficult for students to have available to them unlimited amounts of alcohol. In 2005 Purdue has had to deal with instances that were related to hazing, while steps were taken to appropriately discipline those involved there are further steps that can be taken to prevent risky hazing practices before they happen (Exponent 2005).

Specific Rules and Regulations:

1. No fraternity on the Purdue campus may possess more than 6 cases of beer or 2 kegs at any particular time.

Implementation:

- An on duty officer will randomly be allowed to check the amount of alcohol in rooms and any specified place alcohol may be kept. Typically twice a month.
- One member of each fraternity will be designated to make sure their fraternity is complying with the policy.
- Cost will be minimal, since officers will include checks in their rounds.

Attitudes of Students:

In a survey of students participating in various clubs, and organizations, 76% responded as having been hazed to become members (Walsh 2000). While this doesn't always mean that physical harm may result or other more serious consequences, other sources state that fraternity hazing and the activities that lead up to the actual incident may put the pledges in circumstances that they would normally refuse (Sweet 1999). Talking to students with close ties to fraternities a friend Jeremy Jones had this to say about hazing practices, "It can get out of hand, but it's really kind of funny." This is an indication that hazing is not necessarily a practice that can realistically be eradicated from fraternities anytime soon. However, by decreasing the chances that these practices end in harm we concentrate more on preventing sever consequences rather than dealing with them after they have happened.
